A message from Mary's surgeon

"Mary's sight had gone blurry at least a year before our team met her, but her vision had got so bad, she struggled to help at home, play with friends or even read at school. She was often teased, and at just 10 years old, she spent most of her time alone.

"When our teams finally brought her to the hospital, I could see that cataracts were stealing her sight – and threatening her chances for the future.

"We restored Mary's vision in one, straightforward procedure. Her transformation was incredible – it was like seeing a different girl! She had such a beautiful smile and she was bursting with energy, just like a 10-year-old should be.

"To make such a difference to children's lives is the biggest reward. Every day I get to wake up knowing I'll make a real difference to someone in poverty, who could go on to become a doctor or future leader – all because of people like you. So thank you, for helping to transform lives in my country.

"I feel so lucky to do what I do. I get to help children like Mary escape blindness, so they have the chance to follow their dreams. And I get to be there when a child opens their eyes, and sees the world again.

"Saving sight is a team effort and we just can't do it without supporters like you."

When Sightsavers first met 69-year-old Winesi, cataracts had robbed him of his sight. His sight had been getting worse for more than a decade, which meant he had never seen his 18-month-old grandson, Luka, and it had been 12 years since he had last seen his wife’s face clearly. “I imagine what she looks like, but I can’t remember that well,” he told us.

With Winesi unable to work, his wife Namaleta was struggling to support their family and he worried about their future.

A quick cataract operation changed everything. “Because of my blindness, I wasn’t able to help my family with the harvest. Instead, I was sitting around helplessly while they did all the work. I felt really sad and sometimes I couldn’t hold back my tears. But this year I was able to help harvesting the crops, which was a great relief!

“My illness affected every aspect of our lives. It was like our lives were on hold. Now I am a free man again and can go anywhere by myself. The most important thing is that I can see my wife, my children and my grandchildren. I missed seeing their faces so much.”

Jeremiah Gwafa has been working as an ophthalmic nurse since receiving training from Sightsavers more than 20 years ago and is now working in his local community to help eliminate trachoma in his native Zimbabwe.

Jeremiah sees first-hand the pain trachoma can cause to families in his local community of Binga. “Blindness comes about when the eyelashes turn inward and they scratch the cornea continuously. Now life becomes unbearable for the patient. They live in perpetual pain.”

The advanced stage of trachoma is known as trichiasis, and an operation is often required to avoid permanent blindness.

Sophia, pictured above, was suffering from advanced trachoma and was spending her days on her own at home. Jeremiah performed a straightforward operation on both her eyes and restored her sight as well as her independence.

It was one of 87 operations that Jeremiah delivered that year through the training and support he received from Sightsavers.

Education is key to a child's future, but a visual impairment can impact a child's ability to learn in the classroom. In an innovative programme Sightsavers is now training teachers in schools as a first line in screening their students for a range of eye conditions. Children identified by their teachers are referred to a team of mobile eye health staff. The specialist teams then travel to the school to assess and treat each child. Through this programme free spectacles are provided to children to help correct their vision.

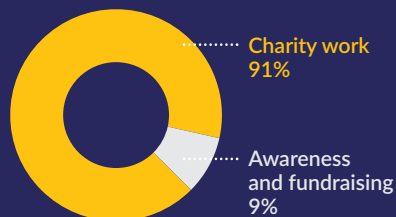
